3. A \$30.00 Check made payable to the Broomfield Symphony Orchestra (application fee is non-refundable)



Youth Concerto Competition Policy

- 1. High School is open to students in 9-12th grade, one winner will be chosen.
2. Middle School is open to students 6-8th grade, one winner will be chosen.
3. Former winners must wait at least 12 months to apply for the same division.
4. Audition spots are available on a first come-first served basis.
5. All applicants should be prepared to play one movement of a chosen concerto.
6. The competition is open to all instruments.
7. All auditions will take place before an audition committee.
8. Transportation to or from the audition is not provided.
9. All applications must be complete, including completed application form, letter of recommendation and application fee, and received by published deadline in order to receive an audition opportunity.
10. Application fee is non-refundable.
11. Audition dates, times and location are not negotiable.
12. An alternate audition date will be provided in the case of severe inclement weather.
13. Notification of audition time will be sent by Friday, March 3rd, 2017 via EMAIL.
14. One piano is available for accompaniment.
15. Competitors must supply their own accompanist for the audition, if needed.
16. Where the name of an accompanist is included in the application the BSO will try to ensure consecutive audition times for applicants using the same accompanist. THIS CANNOT BE GUARANTEED.
17. Competitors will be judged on their mastery of their instrument, musical choice, as well as their stage presence.
18. Audition results will be communicated within two week after final audition date.
19. The 1st place winner of the both Middle School and High School will be invited to perform with the Broomfield Symphony Orchestra at the concerts scheduled for May 24th & May 25th, 2017.
20. Winners agree to provide a headshot and bio that will be used by the BSO for marketing purposes.
21. This policy can be amended at any time without prior notice.
22. The decision of the Audition Committee is final.
23. The Audition Committee can decide not to award prizes, if appropriate as determined by the Committee.

Applicant under age 18: As the parent/guardian of the minor applicant identified on page 1 of this application, I acknowledge that I have read the above rules and regulations and agree to abide by them during the competition process. Failure to abide by these rules and regulations may result in the competitor's disqualification. I agree that my child will abide by them during the competition process.
